Payouts

Projected payouts will be published by September 30, 2025.

Program Foundation

The strength of our futurity lies in the quality and commitment of our stallion owners. The foundation of our program is built upon their annual participation through stallion nominations, which directly support the growth, promotion, and excellence of the Appaloosa halter horse.

Stallion Nomination Options

Option 1: One-Year Enrollment

- Stallion Nomination Fee: **\$1,500**
Due by January 15 each year
- Includes:
 - Featured advertisement on the official futurity website
 - Monthly dedicated posts across our social media platforms

Option 2: Two-Year Enrollment

- **Year 1:** Stallion Nomination Fee: **\$1,500**
Due by January 15
- **Year 2:** Stallion Nomination Fee: **\$1,000**
Due by December 31 of year 1.
- Includes all benefits from the One-Year Enrollment plus a reduced rate for signing a two year enrollment contract.

Eligibility

ApHC and AQHA Stallions enrolled for the **2025 breeding season** will make **2025 weanlings** and **2024 yearlings** eligible for participation in the Futurity events.

Flexibility & Inclusion

In alignment with our **core values**—particularly **Community** and **Integrity**—we recognize that life and business can present unique challenges. To foster an inclusive environment that supports all who are committed to the advancement of the Appaloosa halter horse, the **Futurity Board of Directors** may consider **alternative payment arrangements** under extenuating circumstances. These accommodations will be approached with fairness, discretion, and a shared commitment to strengthening our industry partnerships.

Mare or Foal Owner Responsibilities

Registration Requirements:

All horses must be registered with the Appaloosa Horse Club. Foals born without Appaloosa color or characteristics must have a performance permit issued for all registration numbers beginning with an (N).

Foal Nominations (2025 Foals)

The Futurity Board of Directors has voted to **suspend nomination fees for all 2025 foals** sired by a futurity-eligible stallion. This decision was made to promote accessibility and encourage widespread participation in the futurity's inaugural year under the new organization.

Note: The Board of Directors reserves the right to reinstate foal nomination fees in subsequent years.

Yearling Nominations (2024 Foals)

Similarly, the Board of Directors has also voted to **suspend nomination fees for all yearlings** sired by a futurity-eligible stallion.

Note: The Board of Directors reserves the right to reinstate nomination fees for yearlings in future years as needed.

Futurity Classes at the Appaloosa World Championship Show

Futurity classes will be held the **day prior to the start of the Appaloosa Halter Events** and will include the following divisions:

Weanling Classes

- **Non-Pro Weanling Fillies**
- **Open Weanling Fillies**
- **Non-Pro Weanling Colts & Geldings** (*combined*)
- **Open Weanling Colts & Geldings** (*combined*)

Yearling Class

- **Non-Pro Yearlings** (*all sexes combined*)

Entry Fee: \$425.00 per class

Office Fee: \$30.00 per horse

Important Rule:

The **Futurity Champion** of any Non-Pro or Open **Weanling** class is **ineligible to compete as a Yearling** in the following year's futurity program.

Agreement Terms

By signing this agreement, the Stallion Owner(s), Authorized Agent(s), and Stallion Manager agree to the following:

1. Provide **one (1) print-quality digital advertisement** for inclusion on the official futurity website and social media platforms.

2. Maintain **membership in good standing** with the stallion's breed registry.
3. Maintain **at least one Appaloosa Horse Club (ApHC) membership** authorized to submit breeding reports and issue breeder's certificates for all foals sired.
4. File **stallion breeding reports in accordance with ApHC rules**.
5. **No mares shall be bred prior to February 1st** of any year the stallion is enrolled in the Futurity program.
6. Submit the **initial nomination fee of \$1,500 USD**.

Enrollment Options: ☐ One Year (2025) ☐ Two Year (2026)

- a. All payments are **nonrefundable**. If fees are not paid in full, any payments made will be forfeited and the stallion will not be enrolled.
 - b. If the two year option is selected above, submit the second nomination fee of \$1,000 USD, no later than December 31, 2025.
 - c. In the **event of the death of a stallion**, a substitute stallion may be enrolled if the board is notified within **48 hours**, and **no frozen semen** is available. Substituted stallion's foals will be eligible only for **breedings occurring after the date of death**.
7. Stallions enrolled for the **2025 season** make the following foals eligible to participate:
 - a. Foals born in **2024**
 - b. Foals born in **2025**
 8. All correspondence will be sent to the address listed on this form. It is the **responsibility of the Stallion Owner or Authorized Agent** to provide any updates to the Futurity Secretary.

The Appaloosa Breeder's Halter Futurity Board of Directors reserves the right to determine all rules, regulations, and payouts.
